For over three years I dedicated myself to being the best employee in the company, never missed a day of work, and bent over backwards at every opportunity to help the company prosper.

Which is why it hurt so much when the company turned around and "rewarded" me with a demotion. It was at that moment I decided I was going to take control of my future. A few weeks later, in January of 1985, my company, Carson Services, Inc., was born.

Perhaps inspired by my father's postal service career, Carson Services, Inc., (CSI) started as and grew into a very successful mail-order company. A little over 10 years later, CSI entered into the revolution that was beginning to emerge called the World Wide Web. In 1998, after building our foundation, we officially dubbed our Internet division the SFI Marketing Group (SFI, by the way, stands for Strong Future International) and began growing rapidly.

In fact, in less than five years SFI has expanded into over 200 different countries. In other words, SFI is in *virtually every country in the world!*

Why has SFI experienced such unprecedented growth? I attribute it largely to the unique makeup of our affiliate program—a hybrid combination of the best parts of traditional direct sales and network marketing, combined with the technological advantages of the Internet. It probably also has a lot to do with the simple fact that SFI WORKS.

Indeed, SFI has put millions and millions of dollars into the hands of men and women from all age groups and backgrounds all over the world.

With SFI, you also have my company's nearly 20-year track record behind you. SFI is a longtime member of the Better Business Bureau and Chamber of Commerce. We're also a debt-free company that has expanded to over 600 different products!

SFI: How It Works

While in many ways SFI is revolutionary, what it does is not. Simply put, SFI is just another business method of moving products and services from manufacturers to consumers. What's so different about SFI is that it lets the "little guy" in on the profits!

First, let's look at why major manufacturers are embracing the SFI approach.


Obviously, manufacturers want to get their products into the hands of as many people as possible, and as quickly as possible.

In conventional marketing, however, this may require *millions* of dollars in ongoing advertising expenses. It will also probably require going through layers of middlemen (jobbers, wholesalers, retailers, etc.) – each who want their cut of the profits (while adding ZERO value to the product or service). In addition, the competition can be fierce. And even after spending millions, there's no guarantee of success.

Now consider SFI's business model. With its enormous base of independent affiliates, SFI has the power to reach tens of millions of consumers and businesses worldwide. In return for this broad access, manufacturers provide products to SFI at low, low prices.

The partnership of these manufacturers, SFI, and its independent affiliates is, of course, mutually beneficial. The manufacturer slashes huge amounts of cash from its distribution and sales costs, for example.

And where do all the millions of dollars saved go? *To SFI affiliates, of course,* in the form of commissions and overrides. But in contrast to conventional marketing, the manufacturer now only pays *for results.*



Leveraging Your Income

It's a fact: We all have a maximum of 24 hours a day, which limits the amount of sales an individual can personally generate. That's why SFI also allows you to sponsor other affiliates into SFI and earn override commissions on their efforts, too.



This is one of the most powerful advantages SFI has over other traditional, direct-selling methods. You see, success in conventional direct selling usually means you have to be a super salesman and sell huge amounts of product. SFI is just the opposite. Success in SFI is about a lot of people each doing a little.

Also, unlike most traditional direct selling, SFI isn't a job. On the contrary, it's your own business to run as you like. And no matter when you join SFI, you start out as and will always be the head of your own company. You'll build your own network of independent affiliates and earn a percentage of their sales—yet each is a CEO in their own right, as you are, and each has the opportunity to build their own money-making networks under them.

Do you know what happens when you double a penny every day for a month? At the 15-day mark, it's grown to only \$163.84. But by the 30th day, it's mushroomed to OVER 5 MILLION dollars!

This "leveraging" or duplication effect is one of the most powerful ingredients of SFI. Imagine that you've shared the SFI opportunity with John in Texas. John has an associate in Brazil by the name of Miguel. Miquel comes aboard and soon shares the opportunity with Jean from Sweden. Through Jean's efforts, a Korean, Kim, joins the network.




By just sponsoring one person, you've set into motion a chain of events that now has people working indirectly on your behalf across the globe! And every person (John, Miquel, Jean, and Kim) is each adding to your commission check! This is just one very small example of duplication and networking in action.

Do you think you could find one person each month to join SFI? Just one person a month who might be interested in financial freedom, more leisure time, more security, and more happiness?

Do you think you can teach that one person a month to do what you do? If you can, you can become wildly successful in SFI!

But you know what? Even if you're only able to sponsor someone every three to four months, excellent incomes are still possible. And that's after just your first year. Consider what you can do in year two, year three, and beyond!





Are You On The <u>Anti-Wealth</u> Plan?

Though painful to say, most people go through their entire lives on what I call the "Anti-Wealth Plan." Others call it the "40/40/40" plan. That is, work 40 hours a week for somebody else for 40 years and retire with \$40 in the bank.

That's a bit of an exaggeration, of course, but the U.S. Social Security Board, for example, has reported that 85 out of 100 Americans won't possess as much as \$250 in savings by age 65. And only 2% will be self-sustaining (the rest will be dependent on family, church, or the government)!

The main problem with a typical job is that when YOU stop, the money stops.

MAKE SURE you understand this: If you ever want to acquire real wealth, you're not going to get there trading hours for money.

The world's wealthiest people have known for many decades that if you want financial freedom, you MUST tap into:

1. RESIDUAL INCOME 2. LEVERAGED INCOME

Residual Income is income that keeps coming in month after month, year after year, from work you do just ONCE. It's like a royalty. An example would be writing a book or recording a song and getting paid forever on it. Wouldn't it be absolutely awesome to have that?! Well, with SFI you can!

Leveraged Income is earning money through other people's efforts. There are only 24 hours in a day. Hence, there's only so much you can earn through your own efforts.

With SFI, you can earn Leveraged Income (in the form of "override" commissions) when affiliates you've sponsored to SFI make sales. You can also earn income when they sponsor other affiliates and refer customers to SFI...and when your affiliate's affiliates sponsor other affiliates...and so on...literally to INFINITY.

The fact is, by simply sponsoring a few affiliates to SFI, you can eventually have hundreds even THOUSANDS of affiliates putting money in your pocket around the world...and around the clock!

But that's not even the best part. Each affiliate on your sales team has their own motivation to build and KEEP ON building their businesses and incomes. This, of course, means YOUR income can continue and grow month after month -- even when you want to take a vacation or decide to retire altogether.

Rest assured, there are few things cooler than coming home from a nice relaxing vacation to



find a commission check even bigger than the month before waiting in your mailbox!

Bottom line: With SFI, not only can you earn "do-it-once, get-paid-forever" residual-style income, you also can earn Leveraged Income on the sales of thousands of other affiliates! If building financial security is one of your goals, you've found the vehicle to do it with in SFI.

SAYING "NO" TO ANTI-WEALTH

Every year, SFI pays out millions of dollars in commissions to thousands of SFI affiliates worldwide. Obviously, SFI is working for a LOT of people.

But HOW are they doing it?

For most SFI affiliates, the "secret" is to simply refer people to their SFI Gateway Websites we provide. It's important that you to do this consistently, so that you are creating new sales and/or sponsoring new affiliates every week.

Here's something else that you MUST keep in mind as you begin your marketing campaign: it's a numbers game.

What do we mean by that? Think of your SFI business as a big funnel. In the big end of the funnel you're putting in new affiliates and potential customers. Many will unfortunately turn out to be "tire-kickers" or people looking for something for nothing. That's OK! There are millions of them in the world, and if you're out there advertising, you're going to attract your share. Just accept that and don't let it bother you.

What comes out of the small end of your funnel, however, is the people who "get" SFI, who see the big picture and want to participate seriously. These are your future leaders, and it is through these "go-getters" that you can earn significant income. This is of because SFI pays hefty overrides (Leveraged Income) to you on the activity of those affiliates you personally sponsor to SFI.

But what's REALLY amazing is how few of these go-getters you actually need! Check this out:

Can you personally refer just three new Executive Affiliates a month to SFI and teach them to do the same? If you can, after one year you could easily be earning over \$500 a month (over \$5000 in extra annual income).

Of course, you can earn MUCH, MUCH MORE like many of our affiliates do, but that's the beauty of our business. There are no ceilings. You can earn a little spending cash or you can earn the kind of money that would make your doctor or dentist envious.

Best of all, you can do it completely from home, working only the hours you want. No commute. No suit. And YOU are the boss. As many, many SFI affiliates who live this very lifestyle will tell you, it doesn't get any sweeter than this!



Questions About SFI

Q. Can SFI be done successfully part time?

A. Absolutely... it's very common in fact. You can start your SFI business on a part-time basis without giving up your current source of income until SFI is generating the income you require. And the best part is that you can continue to operate indefinitely on a part-time basis. What would you do if you were financially independent and most of your time was free to do with as you pleased? This is why so many people are flocking to SFI. And that's why we say that SFI puts the freedom back in free enterprise!

Q. Do I have to sell products doorto-door or hold parties or meetings?

A. Only if you wish to. One of the greatest features of SFI is that success can be achieved using a wide variety of methods. You choose the methods that YOU are comfortable with — whether that means Internet marketing, direct mail, telemarketing, meetings, flea markets, in-home parties, or other methods.

Q. How much money can I make?

A. The bottom line is you'll get out of SFI what you put into it. It works...if you do. But that's the beauty of it, too;

you are in control — it's up to you how far you take it. And don't forget, SFI offers the opportunity to earn residual income. This basically means that for the work you do today, you have the potential to earn money not only for today but also potentially for years to come.

Q: Is it really possible to make a large income working at home?

A: According to Entrepreneur magazine, the average home-based business household earns \$50,250 a year. And about 20% of all home-business households earn in excess of \$75,000 a year. And then there are the tax benefits; even if your home business isn't generating a profit yet, it can put \$5,000 or more into your pocket through tax write-offs.

Q. Do I have to sponsor a lot of affiliates to be successful?


A. No, there's actually no requirement to sponsor ANY affiliates. You can earn great money simply selling SFI products. Sponsoring affiliates, however, positions you to earn lucrative leveraged income. Sponsoring just one good affiliate every month or two is all it takes.



Q. Tell me again, what's so important about sponsoring?

A. It's like this: it doesn't matter how intelligent, rich, energetic, or dynamic you are —we are all limited to the same 24 hours a day. By sponsoring, however, you can overcome this limi-

tation. By sponsoring, you can essentially clone yourself and have dozens. hundreds, even thousands of people all working indirectly on your behalf on their time – and receive a cut of everything they do.



Through the process of sponsoring affiliates, however, you can create total financial freedom for yourself. When you've sponsored your own team of independent business people, you no longer have all your eggs in one basket. On the contrary, because each person on your team has a vested interest in continuing and building their own businesses, you create an income that is not dependent upon you - an income that can continue, even grow, indefinitely, with or WITH-OUT you.

Q: SFI sounds to good to be true. There must be fees or something I have to buy right?

A: No. There is NEVER any cost required to be an SFI affiliate. And you can even become an Executive Affiliate for no cost by simply gener-

Q. Do I have to stock and deliver products?


A. Only if you wish to. As an SFI affiliate, your customers can order everything direct from SFI. SFI tracks your commissions and automatically sends you your commission check monthly. SFI also handles all payment processing for your customers, product shipment, customer service, returns, refunds, etc. - all at no cost to you. If you wish to handle stocking and delivering your products yourself, check out SFI's Wholesale Program.

Q. Isn't SFI just another "get-rich-quick" scheme?

A. "Get-rich-quick" is a fairy tale. If overnight riches are your dream, your odds are probably better playing the lottery than going into business — any business. We won't insult your intelligence with promises of overnight wealth. That said, we've paid out many millions of dollars to our affili-

ates who've applied themselves.

Indeed, as thousands of our affiliates will attest, there's huge money to be made in SFI if you're willing to do the work.



Of course, to become successful, ANY business requires some sort of investment. If your budget is small, you'll need to at least invest TIME in marketing and pursuing customers.

You can utilize free classified ads on the Internet, and there are many, many other creative ways to market your business both online and offline inexpensively.



Q. What are the costs involved in starting and operating an SFI business?

A. This is one of the most powerful features of SFI. It's completely free to become an SFI affiliate and there's NEVER a requirement to purchase anything. Compare that to buying a franchise. Even a lesser-known franchise can require an investment of tens of thousands of dollars — and that's just to get started.

On top of that, with a franchise you'll



other words, even if profits are not immediately generated, you can significantly lower your tax bill.

Q. I understand I'm not required to buy products from SFI, but is there a reason I should consider it?

A. Yes! One of the many great benefits of being an SFI affiliate is that you

can purchase many of our products at WHOLESALE... up to 67% off retail! Hence, you can actually save money buying from SFI. Plus, it only makes sense to buy from yourself — to buy from what is,



Q. I have no experience with running a business. Can I really succeed with SFI?

A. There are no guarantees, of course, but people of every age, every background, from every walk of life, and from all over the world are making it in SFI today. SFI was designed for the "little guy"! If you have the desire, you can succeed with SFI.

Q. I'd like to get serious building an SFI business, but I just don't have the time. What should I do?

A. That's precisely why you should consider SFI. Besides creating financial freedom, SFI has been specifically designed to create personal freedom for you so that you can do all the

things in life you really want to do that you don't have the time for now.

Q. I'm not a salesperson, so this probably isn't for me.

A. Actually, people with no sales experience do great in SFI. This is because SFI isn't about selling – at least not in the way most people

think of selling.

for "arm twisting"
or high-pressure

Rather, SFI is simply about sharing
the products that
you use and are
excited about.

Q. Is SFI a pyramid scheme?

A. Definitely not. In pyramid schemes, income is generated solely on the process of recruiting others into the pyramid. Sometimes a product or service of questionable value is involved (that is never retailed to the general public), but generally what you're buying is the right to recruit others into the scheme. This is illegal.

Also, in pyramid schemes, those who get in first and who are at the top win, while everybody else loses. In SFI, on the other hand, there is no cost required to participate and affiliates are paid only on product sales (both at wholesale and retail) — and never on recruiting.

SFI also provides compensation based on the training, support, and managing of your marketing team. And, unlike illegal pyramids, in SFI, no



matter where you're positioned or when you join, you can advance to the very highest income levels and even earn more income than those above you in the network.

Q. Don't you have to get in at the beginning to make any real money? Doesn't saturation eventually occur?

A. SFI is still a very young company. There are literally billions of prospects worldwide who have never even heard of SFI. It will take many years to even make a dent in that.

But here's the main reason why "saturation" is a myth: timing. In the U.S. alone, tens of thousands of brand new prospects are "hatched" every year. Part of that figure is young adults who have only just reached the stage in their lives where they'd consider (and could afford) to start a business.

Then there are the thousands who have just experienced a major shift in the direction of their lives because of changes at work, at home, etc. These same people, who just months before could in no way be considered prospects for SFI, NOW are suddenly very open to the proposition. And this is happening constantly. Bottom line: The market is wide open and the potential is enormous.

Q. Is SFI a "real" business?

A. It's very real. SFI is part of a grow-

ing global industry with annual gross revenues estimated at over \$100 bill-lion, involving major multinational corporations and tens of millions of independent business people in every country of the world.

Q. I've tried businesses like SFI before and it didn't work for me.

A. Let's say you've just moved into a new city, and you decided to go out to eat that evening. Unfortunately, the food at the restaurant you picked turned out to be horrible. But just because of this one bad experience, you surely wouldn't swear off eating at all the other restaurants in the city, would you? Of course not! It's the same thing here. You just need to link up with the right company — a company like SFI.

Q: Isn't having a traditional job safer than going into business for myself?

A: That depends on your definition of "safe." In the United States, statistics show that out of every 100 people who start in the working world at age 20, only five will be financially independent by age 65. Undoubtedly, you want to be in the five percentile. Unfortunately, the odds are stacked heavily against you... unless you create an independent source of income — a business of your own that is limited only by your own desire and ability... a business like SFI.


